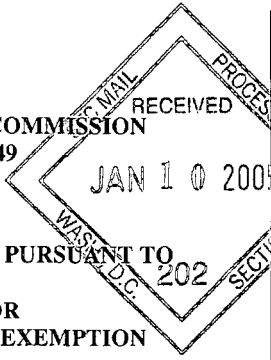

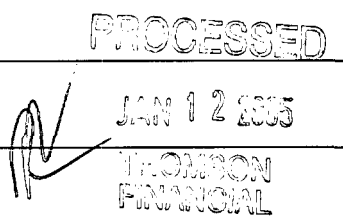

Filing Fee: There is no federal filing fee.
