## EXHIBIT A

Sepia Commodity Fund, LP ("Partnership") is a limited partnership formed to pool investment funds of its investors for the purpose of investing and trading in a wide variety of securities and financial instruments, domestic and foreign, both long and short, primarily focusing on commodities and commodity-linked instruments, inflation-linked fixed-income securities, swaps, options and futures. Generally, new Limited Partners will be admitted on the first day of each month. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
