

EXHIBIT A

Great Gable Offshore Fund, Ltd. ("Company") is a Cayman Islands exempted company that was formed to pool investment funds of its investors for the purpose of investing and trading in a wide variety of securities and financial instruments, domestic and foreign, primarily focusing on publicly traded equity securities, fixed income and foreign exchange markets, all as determined by the Investment Manager in its sole discretion subject to the policies and control of the Board of Directors. Generally, Shares may be purchased on a monthly basis. Although there is no maximum or minimum aggregate amount of shares which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares.
