



\* An affiliate made a loan of \$7,533,100 in order to provide funds for the acquisition of the partnership interests and to cover expenses. This loan, together with \$68,635 of interest, was repaid from proceeds of the offering. \$321,000 of the principal amount of the loan was satisfied by the assignment to the affiliate of interests in the issuer.
