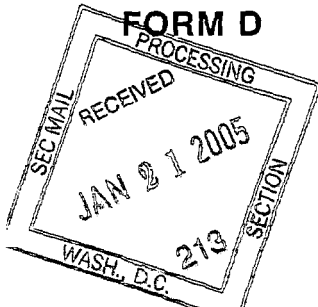



* The general partner and its assignees will receive a quarterly cash fee in an amount equal to .25% aggregate of partner capital account balances and a yearly incentive profit allocation equal to up to 10% of net profits subject to a high water mark.
