



## EXHIBIT A

Provenia Offshore Fund, Ltd (the "Fund") is a private investment fund formed to pool the assets of its investors for the purpose of investing and trading in a wide variety of securities and financial instruments, U.S. and non-U.S., primarily focusing on publicly traded mortgage-backed and other fixed income securities. The Fund is offering shares to persons and entities outside of the United States and to qualified U.S. investors on a continuous basis. Although there is no maximum or minimum aggregate amount of shares which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares.
