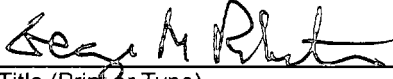

## EXHIBIT A

Provenia Partners, LP (the "Partnership") is a private investment fund formed to pool the assets of its limited partners for the purpose of investing, directly or indirectly, in a wide variety of securities and other financial instruments.
