



**Exhibit A to the Form D of Bonanza Resources Corporation**

A total of 1,851,250 units were sold in the offering at a price of \$0.16 CDN (\$0.128 U.S.) per unit. Each unit consists of one common share and one share purchase warrant, with each warrant entitling the holder to purchase one additional common share at a price of \$0.20 CDN (\$0.16 U.S.) until January 27, 2007.

A total of 287,500 of these units were sold in the United States to two accredited investors, one in the State of California and the other in the State of Texas. The remaining 1,563,750 units were sold in Canada.

The offering was effected in the United States pursuant to Regulation D and outside of the United States pursuant to Regulation S.
