

## EXHIBIT A

Winchester Fund of Funds, LP (“Partnership”) was formed to pool investment funds of its investors and the General Partner together with Limited Partners to be managed by a number of investment managers selected by the Sub-advisor. The Limited Partners, by pooling their assets in the Partnership, will be able to indirectly invest their funds in various portfolios of securities managed by various investment managers selected by the Sub-advisor. Generally, new Limited Partners will be admitted on the first day of each month. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
