

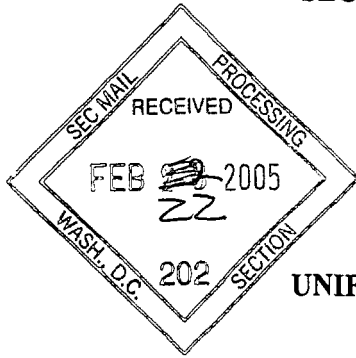





GraphOn Corporation ("GraphOn") issued an aggregate of 9,599,993 shares of Common Stock, par value \$0.0001 per share, to certain shareholders and claimants of Network Engineering Software, Inc., a California corporation ("NES"), upon consummation of the merger of GraphOn Via Sub III, Inc., a Delaware corporation and a wholly-owned subsidiary of GraphOn ("Sub I") with and into NES pursuant to an Agreement and Plan of Merger and Reorganization among GraphOn, NES, Sub I, GraphOn NES Sub, LLC, a California limited liability company and certain shareholders of NES (the "Merger").

The Merger was consummated on January 31, 2005 (the "Effective Date"). In connection with the Merger, (a) Sub I was merged with and into NES, (b) each share of common stock of NES was converted 97.9511 shares of Common Stock of GraphOn and (c) each share of common stock of Sub I was converted into one share of common stock of NES.
