



The Issuer has sold 769,500 units (the “Units”) at a purchase price of \$0.52 CDN per Unit for total proceeds of \$332,117 U.S. Each unit consists of one fully paid and non-assessable common share of the Issuer and one-half of a transferable share purchase warrant. Each warrant shall entitle the holder thereof to purchase one additional share in the capital of the Issuer at an exercise price of \$0.65 CDN per share for a two year period.

Of the Units sold, a total of 187,500 Units were sold into the United States for proceeds of \$80,925 U.S.

The offering was effected in the United States pursuant to Regulation D and outside the U.S. pursuant to Regulation S.
