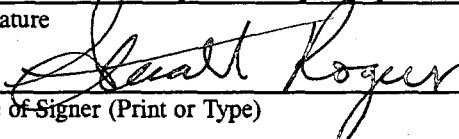

The Issuer has sold 1,310,000 units (the "Units") at a purchase price of \$0.30 CDN per Unit for total proceeds of \$322,260 U.S. Each unit consists of one fully paid and non-assessable common share of the Issuer and one transferable share purchase warrant. Each warrant shall entitle the holder thereof to purchase one additional share in the capital of the Issuer at an exercise price of \$0.60 CDN per share for an eighteen month period.

Of the Units sold, a total of 270,000 Units were sold into the United States for proceeds of \$66,420 U.S.

The offering was effected in the United States pursuant to Regulation D and outside the U.S. pursuant to Regulation S.
