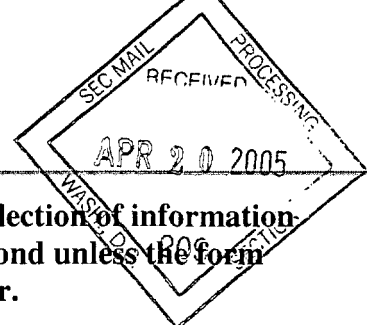

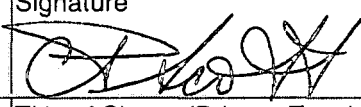

The offering is for an aggregate of 18,500,000 units ("Units") at a price of CND \$0.50 (being equivalent to US \$0.4180 based on an exchange rate of 0.8196 as of April 5, 2005) per Unit, each unit consisting of one common share and one-half of one common share purchase warrant (with each whole warrant being exercisable for one common share at a price of Cdn. \$0.60 per common share at any time until April 5, 2007) and 2,500,000 common shares on a flow-through basis ("Flow-Through Shares"). There were an aggregate total of 3,172,000 Units sold in the US at a price of CND \$0.50 per Unit. There were no Flow-Through Shares sold in the US. The offering was effected in the US pursuant to Regulation D and outside the US pursuant to Regulation S.
