## EXHIBIT A

Crossfields Fund I LP ("Partnership") is a limited partnership formed to pool investment funds of its investors for the purpose of investing and trading in a variety of securities and financial instruments, domestic and foreign, primarily in publicly traded equity securities. The limited partnership interests (the "Interests") will be offered on a continuous basis to persons who are Accredited Investors. Although there is no maximum or minimum aggregate amount of Interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such Interests.
