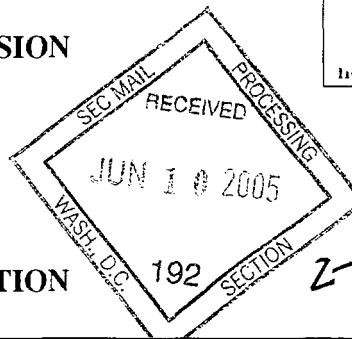

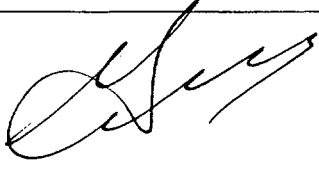

Aggregate Offering Price:

This is a continuous offering commercial paper program consisting of short-term promissory notes of BHP Billiton Limited, BHP Billiton Plc, BHP Billiton Finance (USA) Limited and BHP Billiton Finance (USA) B.V. (the "Issuers"). Figure represents the maximum amount of short-term notes of all of the Issuers that are authorized to be outstanding under the program at any one time.

Number of Investors

The notes are offered on a continuous basis to or through the dealers either as agents for the issuer or as principals. Accordingly, it is not practicable for any of the four Issuers to determine the number of investors who beneficially own the notes at any one time.

Sales Commissions

Notes are typically offered and sold to investors or dealers at par (without paying any sales commissions or deducting any discounts). Depending on market conditions, however, the Issuers may from time to time pay the dealers sales commissions or sell notes less a discount from the purchase price. Because it is impracticable for any of the four Issuers to estimate whether any such commissions will be paid or discounts deducted over the life of the commercial paper program, for purposes of this Form D it is assumed that all notes will be sold at par.
