¹ The Issuer will pay all expenses associated with its formation and the offering, including legal and accounting fees, filing fees, printing and mailing. The Issuer will pay all expenses associated with the administrator's fees. Such expenses will be computed at an annual rate equal to 0.13% of the fair market value of the Issuer.
