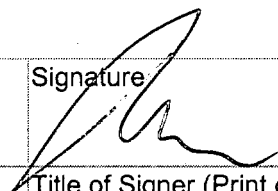

Imperial Metals Corporation (“Imperial”) will issue up to 1,935,750 Warrants (the “Warrants”) in consideration for a working capital facility of US\$11,483,333 (Cdn \$14.5 million). Each warrant entitles the holder to purchase one common share of Imperial at the price of US\$4.75 (Cdn \$6.00) per share, subject to adjustment, for a term of 24 months from the date of issue. The Warrants will be issued as the facility is drawn upon.

1,001,250 Warrants have been issued thus far, with 172,629 of those Warrants issued to a Connecticut investor, having a total value of approximately US\$1,024,078.

The offering was effected in the United States pursuant to Regulation D and outside of the United States pursuant to Regulation S.
