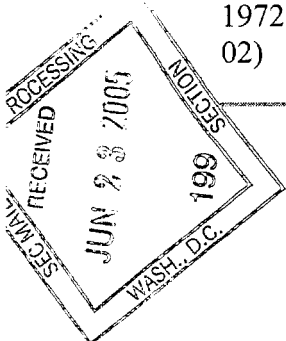

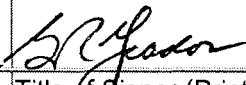

Exhibit A to the Form D of Dynamite Resources Ltd.

A total of 1,000,000 units were sold in the offering at a price of \$0.36 (U.S.) per unit. Each unit consists of one common share and one share purchase warrant, with each warrant entitling the holder to purchase one additional common share at a price of \$0.60 (U.S.) until June 7, 2007.

A total of 320,000 of these units were sold in the United States to accredited investors in the State of California, the remaining 680,000 units having been sold in Canada in the Provinces of British Columbia and Ontario, and in the United Kingdom.

The offering was effected in the United States pursuant to Regulation D and outside of the United States pursuant to Regulation S.
