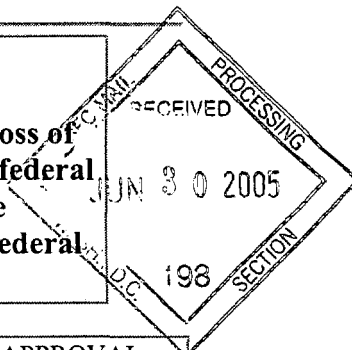

Exhibit A to the Form D of Bashaw Capital Corp.

A total of 4,000,000 units were issued pursuant to the offering at a deemed price of \$0.40 (U.S.) per unit. Each unit consists of one common share and one share purchase warrant, with each warrant entitling the holder to purchase one additional common share at a price of \$0.60 (U.S.) until June 7, 2007. These units were issued by Bashaw Capital Corp. in conjunction with its acquisition of all of the issued and outstanding shares of Dynamite Resources Ltd., which is a private corporation incorporated under the laws of British Columbia, Canada pursuant to a "three cornered amalgamation".

A total of 320,000 of these units were issued in the United States to accredited investors in the State of California, the remaining 3,680,000 units having been issued to persons resident in Canada in the Provinces of British Columbia, Alberta and Ontario and in the Yukon Territory, and to persons resident in the United Kingdom.

The offering was effected in the United States pursuant to Regulation D and outside of the United States pursuant to Regulation S.
