



## Exhibit A to Form D

The Issuer has sold 2,595,400 of its common shares (the "Shares") at a purchase price of \$0.41 US per Share for total proceeds of \$1,064,998 US.

Of the Shares sold, 150,400 were sold into the United States for proceeds of \$61,715 US.
