



Exhibit A to Form D

A total of 2,260,250 common shares and 3,673,281 units were sold in the offering at a price of \$0.40 CDN (\$0.32 U.S.) per common share and \$0.35 CDN (\$0.28 U.S.) per unit. Each unit consists of one common share and one-half of one share purchase warrant, with each whole warrant entitling the holder to purchase one additional common share at a price of \$0.50 CDN (\$0.40 U.S.) until August 9, 2007.

A total of 566,435 of these units were sold in the United States to six accredited investors in the States of California (2), New York (2), New Jersey (1) and Washington (1). The remaining 2,260,250 common shares and the remaining 3,106,850 units were sold in Canada and other foreign jurisdictions.

A commission consisting of US \$1,600 and 8,572 share purchase warrants, each entitling the holder to purchase an additional common share at a price of US \$0.32 in the first year and US \$0.44 in the second year, was paid to Pacific International Securities (US) Inc. with respect to one accredited investor in the State of New York (71,435 units).

The offering was effected in the United States pursuant to Regulation D and outside of the United States pursuant to Regulation S.
