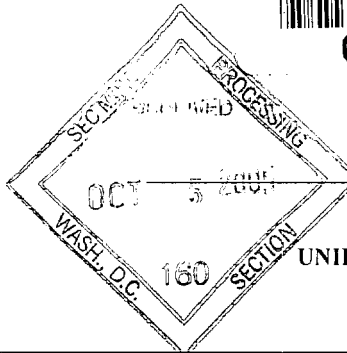



Commencing on or after December 21, 2004, upon the satisfaction of certain conditions as stated in the partnership agreement of the issuer (the “Partnership Agreement”) and continuing until September 21, 2010, the issuer will pay Shamrock Capital Advisors, Inc., as manager of the issuer, an annual fee equal to 2.00% per annum of the aggregate capital commitments of the investors up to \$120 million and 1.75% per annum of the aggregate capital commitments of the investors in excess of \$120 million. 
