

The Issuer has sold 2,960,617 of its Common shares (the "Shares") at an average price of \$0.1709 per Share for total proceeds of \$498,331 US.

Of the Shares sold, 75,000 were sold into the United States for proceeds of \$12,624 US.

No finders fees were or will be paid in respect of purchases by U.S. resident purchasers, although \$12,731 will be paid regarding various Canadian resident purchasers.
