## Exhibit "A" to Form D

1. The total number of units sold in the offering was 2,400,000 units at a price of \$0.216 USD (\$0.25 CAD) per unit for a total offering amount of \$518,493 USD (\$600,000 CAD). Each unit consists of one common share and one-half of one transferable warrant, with each whole warrant entitling the owner thereof to purchase one additional share within 2 years of the closing date (December 6, 2005), at an exercise price of \$0.35 CAD.
2. The total number of units sold in the United States is 370,000 units for a total of \$79,920 USD (\$92,500 CAD).
