

DATA CALL TECHNOLOGIES, FORMERLY DATA CALL WIRELESS ("DATA CALL") SOLD 2,044,000 SHARES OF COMMON STOCK AT \$0.10 PER SHARE TO TWENTY TWO (22) NON-ACCREDITED INVESTORS FOR A TOTAL OF \$204,400, BETWEEN APRIL 2002 AND SEPTEMBER 2005. SUBSEQUENT TO SEPTEMBER 2005, DATA CALL DETERMINED THAT THOSE SHAREHOLDERS MAY NOT HAVE RECEIVED ADEQUATE DISCLOSURES REGARDING THE COMPANY IN CONNECTION WITH THEIR PURCHASES AND AS SUCH, ALL TWENTY-TWO INVESTORS WERE OFFERED RESCISSION OF THEIR PURCHASES. 
