(2) This Form D is being filed in connection with the private placement and issuance of (i) a new series of preferred stock designated as Series A-1 Convertible Preferred Stock (the "Series A-1 Preferred Stock"), and (ii) warrants to purchase one share of the Issuer's common stock at an exercise price of \$0.0903 per share (the "Warrants"). The Series A-1 Preferred Stock and the Warrants will be sold for an aggregate minimum purchase price of \$6 million and up to a maximum of \$15 million at one or more closings. At the initial closing, purchasers of the Issuer's Series A-1 Preferred Stock will also be issued Warrants to acquire one share of the Issuer's common stock per share of Series A-1 Preferred Stock purchased by them. 
