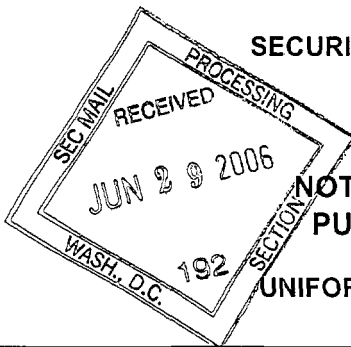

## EXHIBIT A

SRS Private Investments US, LP ("Partnership") is a Delaware limited partnership organized for the purpose of investing and trading in a wide variety of Indian real estate and private equity assets. The Partnership's minimum investment amount is \$5,000,000, although the general partner of the Partnership has discretion to accept lesser amounts. The interests will be continuously offered in the sole discretion of the general partner of the Partnership, SRS Private Investments US GP, LLC. Although there is no maximum or minimum aggregate amount of limited partner interests which may be sold in this continuous offering, we have inserted the figure of \$250,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partner interests.
