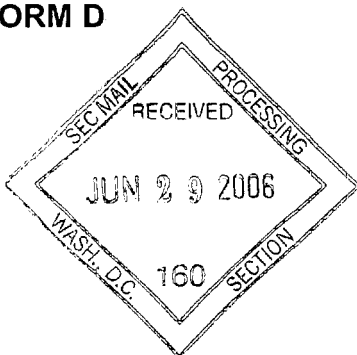

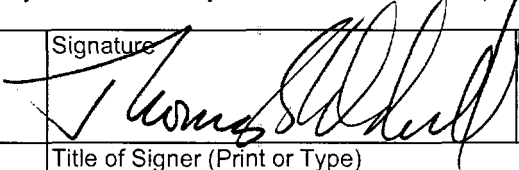

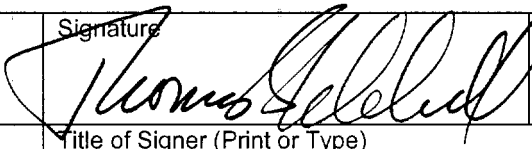

## EXHIBIT A

Caldwell Advantage, LP ("Partnership") is a limited partnership organized for the purpose of investing and trading in a wide variety of securities and financial instruments, domestic and foreign, of all kinds and descriptions, whether publicly traded or privately placed, including, but not limited to, common and preferred stocks, bonds and other debt securities, convertible securities, limited partnership interests, mutual fund shares, options, warrants, commodities, futures, derivatives (including swaps, forward contracts and structured instruments), currencies, monetary instruments and cash and cash equivalents. The Partnership's minimum investment amount is \$100,000, although the general partner has discretion to accept lesser amounts. The interests will be continuously offered in the sole discretion of the general partner of the Partnership, Caldwell Fund Management, LLC. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
