Brief Description of Business: Infra-Com Technologies Inc. focuses on the development and commercialization of low cost, indoor, short-range wireless chipsets. Infra-Com has achieved a significant technological innovation by realizing Non-Line-Of-Sight (NLOS), and Non-Directional optical wireless communication links at high bit rates. Infra-Com's first chipset is a low cost infrared PHY termed IrGT801A. This chipset enables short-range NLOS wireless communication, and is to be embedded into various Home Entertainment devices such as DVDs, HT-BS Home Theater in a Box and Receiver/Amplifiers, as well as their related surround and subwoofer speakers.

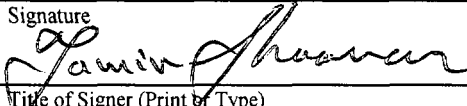
