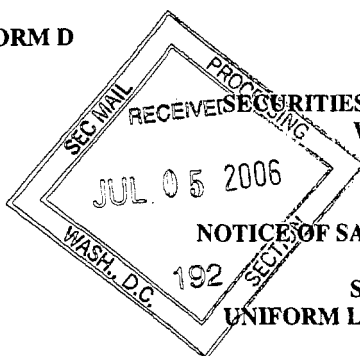

Part E and the Appendix need not be filed with the SEC.
