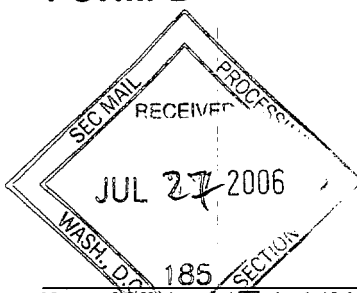

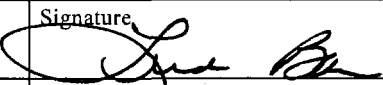

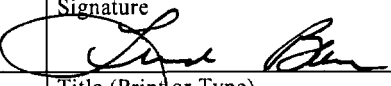

Item 2, Minimum Investment. The minimum investment is \$5,000,000, unless waived by the General Partner.

Footnote to Section C: Offering Price, Number of Investors, Expenses and Use of Proceeds

Item 1, Amount Already Sold: This amount reflects assets received from approximately 17 foreign investors.

Item 2, Number of Investors: This number reflects approximately 17 foreign investors.

Salaries and Fees.

A management fee is payable by the Issuer to the Investment Manager payable quarterly in advance, in an amount equal to 1.50% per annum of the aggregate capital commitments of the partners (other than affiliates of The TCW Group, Inc. or any employees, shareholders, officers or directors of any of these entities or any entity whose equity holders are comprised of the foregoing.), during the Investment Period of the Fund. After the Investment Period, the management fee will equal 1.25% per annum of the aggregate amount of invested capital.

The Issuer is required to pay its annual operating expenses which cannot be estimated at the present time. All organizational and offering expenses incurred in conjunction with the establishment of the Partnership, the start up of its investment activities and the sale of LP interests will be reimbursed to the General Partner by the Partnership in an amount up to \$1,700,000. To the extent such organizational and offering expenses exceed this amount, they will be borne by the General Partner.
