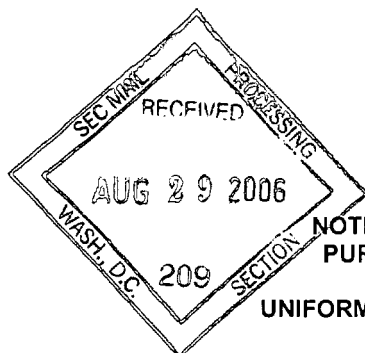

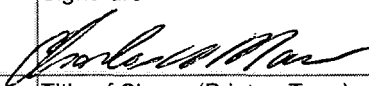

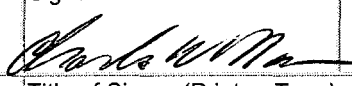

NOTE TO FORM D
OF RAD ELECTRONICS, INC.

RAD Electronics, Inc. (the "Company") is offering shares of its Series A-2 Redeemable Convertible Participating Preferred Stock ("Series A-2 Preferred Stock") at an aggregate offering price of \$4,500,000 (with an accompanying warrant to purchase Series A-2 Preferred Stock of the Company). The Series A-2 Preferred Stock is convertible into common stock of the Company. The warrant that accompanies the Series A-2 Preferred Stock will be exercisable into 25% of the number of shares of Series A-2 Preferred Stock of the Company purchased by each investor, with an exercise price of \$0.01 per share, subject to adjustment from time to time. The warrant is exercisable for a period of three years from date of issuance. The aggregate offering price shown in item C.1. of this Form D includes both the current aggregate offering price of the Series A-2 Preferred Stock (i.e., \$4,500,000) and the current aggregate exercise price of the accompanying warrants (i.e., \$11,250). All of the securities described above (including any securities into which the same may be converted or for which the warrant may be exercised as well as any securities into which such securities may be converted) are included in the offering for which the Form D is being filed.
