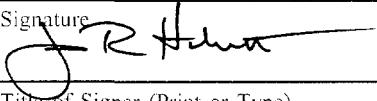

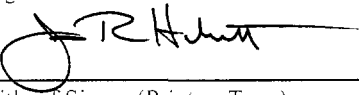

Addendum to Form D
