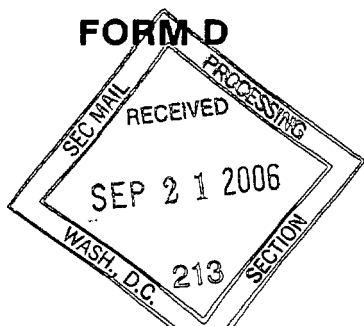

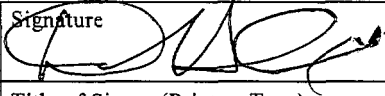

* The general partner and its assignees will receive a quarterly cash fee in an amount equal to 0.50% of the aggregate capital account balances of the Limited Partners at the beginning of each calendar quarter and a quarterly performance allocation of 20% of the net profits (including net unrealized profits) generated in the account of each Limited Partner during the calendar quarter, subject to a "high water mark". The Issuer will also reimburse the general partner and its affiliates for approximately \$45,000 of organizational and initial offering expenses.
