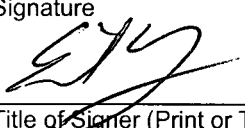

## EXHIBIT A

Cedar Hill Private Capital, LP ("Partnership") is a Delaware limited partnership organized for the purpose of investing indirectly through the master fund, Cedar Hill Private Capital Master Fund, L.P., primarily in non-U.S. securities, commodities and derivatives exchanges and related investments. The Partnership's minimum investment amount is \$5,000,000, although the general partner of the Partnership, Cedar Hill Private Capital GP, LLC ("General Partner") has discretion to accept lesser amounts. The interests will be continuously offered in the sole discretion of the General Partner. Although there is no maximum aggregate amount of limited partner interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partner interests.
