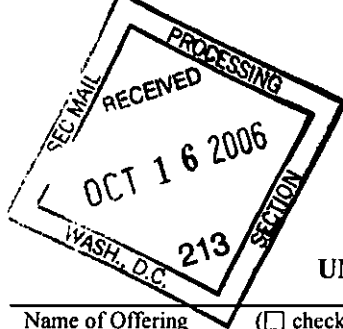





ISSUER: Starfish California Fund I, LP: Offering of Limited Partnership Interests

Aggregate Offering Price

This is the estimated aggregate offering price. However, there is no predetermined maximum offering price; the Issuer is an open-ended Delaware limited partnership for which limited partnership interests are offered continually. Limited Partners may be admitted to the Partnership on a quarterly basis.

Salaries and Fees

A management fee is payable by the Issuer to its General Partner based on the adjusted net asset value of the Issuer. The annual fee (payable quarterly) charged to each limited partner will be 1% per annum.
