* The placement agent will receive a commission equal to (i) eight percent of the gross proceeds, payable in either cash or Series B Convertible Preferred Stock (the "Preferred Stock"); (ii) 7-year Warrants to purchase Preferred Stock at an exercise price equal to 110% of the purchase price of the Preferred Stock for a number of shares of Preferred Stock equal to 10% of the gross proceeds from the sale of the Preferred Stock, divided by the purchase price (\$1.20 per share) and (iii) expense reimbursements of 2% of the price of the Preferred Stock it sells (subject to a limit of \$40,000).
