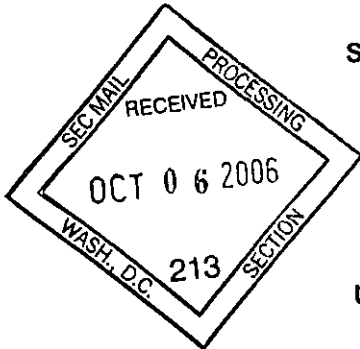

## EXHIBIT A

Kinglier Capital, LP ("Partnership") is a limited partnership organized for the purpose of investing and trading in a wide variety of investments, domestic and foreign, of all kinds and descriptions, whether publicly traded or privately placed, including but not limited to common and preferred stocks, bonds and other debt securities, convertible securities, limited partnership interests, mutual fund shares, options, warrants, futures, derivatives (including swaps, forward contracts and structured instruments), monetary instruments, other financial instruments, cash and cash equivalents.. The Partnership's minimum investment amount is \$500,000, although the general partner has discretion to accept lesser amounts. The interests will be continuously offered in the sole discretion of the general partner of the Partnership, Kinglier Capital Partners, LLC. Although there is a maximum aggregate amount of limited partnership interests which may be sold in this continuous offering, which is \$200,000,000 in Part C(1) of Form D of the aggregate offering price of such limited partnership interests.
