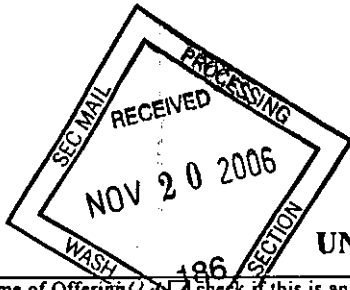

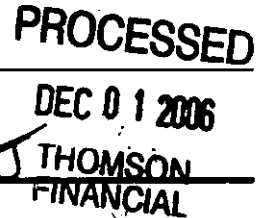

AMOUNT OF PURCHASES

The amount "purchased" under the 2007 Nonqualified Deferred Compensation Plan (the "2007 Plan") cannot be determined at this time.
