
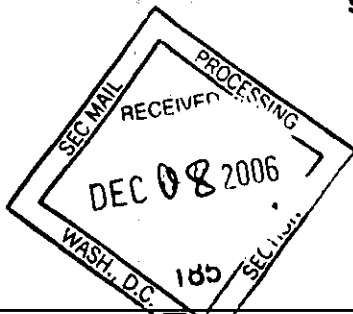



EXHIBIT A

Tunnelbrook Deep Blue Fund Ltd. ("Company") is a Cayman Islands Exempted Company organized for the purpose of investing and trading in a wide variety of securities and financial instruments, long and short, domestic and foreign, primarily focusing on publicly traded equity securities. The Company's minimum investment amount is \$1,000,000, although the Company has discretion to accept lesser amounts. The interests will be continuously offered in the sole discretion of the Company. Although there is no maximum aggregate amount of shareholder interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares of stock.
