



### The Forma Group, Incorporated

#### Section C. Offering Price, Number of Investors, Expenses and Use of Proceeds.

2. Of the 10 investors, 4 had invested in an entity which owned and developed a proof of concept home for the issuer, The Forma Group, Incorporated. As a part of that transaction, the 4 individuals received the right to roll over their investment in the other entity into the issuer at a preset share price after the proof of concept project was successfully completed and profitably sold, which they did at that time.

4. Legal and accounting expenses were not separately identified as related to the offering, and were deemed to be immaterial to the size of the offering.
