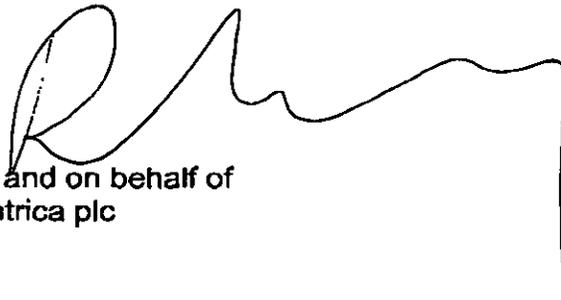

At the date of this notice, the issued capital of the Company comprises 3,676,262,304 ordinary shares. All of these shares carry voting rights of one vote per share.
