



## Exhibit A

Topos Equity Onshore Feeder Fund LLC (the "Fund") is a private investment fund formed to pool the assets of its investors for the purpose of investing, directly or indirectly, in a wide variety of securities and other financial instruments. The Fund is offering limited liability company interests on a continuous basis to qualified investors. Although there is no maximum or minimum aggregate amount of limited liability company interests which may be sold in this continuous offering, we have inserted the figure \$100,000,000 in Part C (1) of Form D as a reasonable estimate of the aggregate offering price of such limited liability company interests.
