## EXHIBIT A

India Equity Growth Fund (Delaware) LLC ("Company") is a limited liability company which will invest substantially all of its assets in India Equity Growth Fund Limited, a Mauritius umbrella fund company ("Master Fund"), through a "master-feeder" fund structure. The Fund was formed to pool investment funds of its investors for the purpose of investing in the Class A Shares of the Master Fund. The Master Fund was formed for the purpose of generating long-term capital growth by making investments in equity securities of Indian companies through derivative and synthetic products. The Master Fund may also invest directly in Indian listed and unlisted securities subject to prevailing Indian regulations. The Company's minimum investment amount is \$500,000, although the Board of Managers of the Company has discretion to accept lesser amounts. The membership interests of the Company will be continuously offered in the sole discretion of the Board of Managers. Although there is no maximum or minimum aggregate amount of membership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such membership interests.
