



The Offering closed on January 16, 2007. The Issuer offered and sold 952,000 of its Units (the "Units"), each Unit consisting of one common share ("Share") and one common share purchase warrant ("Warrant"), at a price of \$0.4448 USD [\$0.50 CDN] per Unit for a total aggregate offering amount of \$423,450 USD [\$476,000 CDN]. Each warrant is exercisable into a common share of the Issuer for a period the earlier of one year from the date of issue or one year from the date the British Columbia Securities Commission issues a receipt for the Issuer's final prospectus at an exercise price of \$0.75 CAD.

The Units were offered and sold outside the United States in accordance with Rule 903(b)(1) of Regulation S and within the United States in accordance with Rule 506 of Regulation D.

"Item C.2" of Form D

Of the total Units offered and sold in this Offering, 268,000 Units were sold in the United States by the Issuer for gross proceeds of \$119,206 US [\$134,000 CAD].

These offers and sales of Units were made in accordance with Rule 506 of Regulation D by certain officers and directors of the Issuer to "Accredited Investors," as defined in Rule 501(a) of Regulation D, residing in the following states: Arizona, California and Ohio.
