AMOUNT OF PURCHASES

The amount "purchased" under the 2006 Nonqualified Deferred Compensation Plan (the "2006 Plan") could not be determined at the time the offering commenced.

Under the 2006 Plan, each participant determined the percentage of eligible compensation to be deferred for the plan year (January 1, 2006 to December 31, 2006). Each participant's eligible compensation included, among other components, bonuses, incentive compensation and commissions (such bonuses, incentive compensation and commissions are in no way related to the offering of participations in the 2006 Plan). The total amount of eligible compensation that could be earned by participants in the 2006 Plan could not be determined until the compensation was earned, which did not occur, as to certain types of compensation, until after expiration of the plan year. Therefore, the amount of compensation to be deferred under the 2006 Plan could not be determined until the end of the plan year.

This Amendment reflects the total amount deferred under the 2006 Plan; no further amounts may be deferred.

The information set forth on the Appendix as to the number of accredited investors and amount purchased is based on the state of residence of each investor, which may differ from the state in which the investor works for FMR Corp. or a subsidiary thereof, and reflects the number of actual investors, rather than the number of persons offered participations during the 2006 Plan's offering period, as reflected in the original Form D relating to the 2006 Plan.
