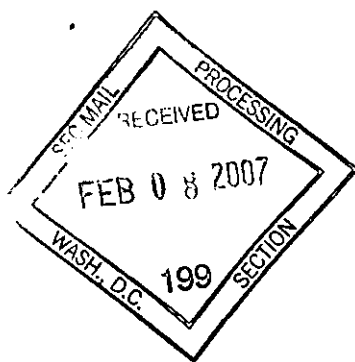

The warrants are exercisable for a period of five years, beginning six months after the date of issuance, at an exercise price of \$0.61 per share.

** The placement agent agreed to accept the \$173,845.91 cash portion of its commission in common stock and warrants on the same terms as the investors, which resulted in the placement agent receiving 316,084 shares of common stock and warrants to purchase an aggregate of 126,434 shares of common stock. In addition, the placement agent received a warrant to purchase 173,846 shares of common stock, which is exercisable for a period of five years, beginning six months after the date of issuance, at an exercise price of \$1.00 per share.
