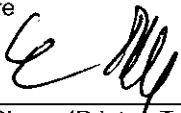

EXHIBIT A

Clarus Capital LLC ("Company") is a limited liability company organized with a principal investment objective, which is to generate high returns in all market conditions by employing a value-oriented, research intensive approach to investing in U.S. equities. The Partnership's minimum investment amount is \$250,000, although Clarus Capital Advisors, LLC ("Managing Member") has discretion to accept lesser amounts. The interests will be continuously offered in the sole discretion of the Managing Member. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
