



* The investment manager will receive a monthly cash fee in an amount equal to 0.0833% of net assets and a yearly incentive fee equal to 20% of net capital appreciation.

In addition, the issuer will reimburse Lauren Templeton Capital Management, LLC and its affiliates approximately \$21,000 of organizational expenses and \$9,000 of offering expenses advanced on behalf of the issuer.
