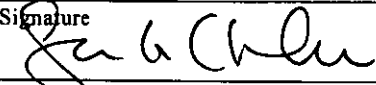

- * The general partner and its assignees will receive a quarterly cash fee in an amount equal to .25% of partner capital account balances and a yearly incentive profit allocation equal to 20% of the net profit subject to a "high water mark". The Issuer will also reimburse the general partner and its affiliates for approximately \$30,000 of organizational and initial offering expenses once the Issuer has received \$2,000,000 of capital contributions.
